TO PROMOTE ACADEMIC AND RESEARCH COOPERATION

This Memorandum of Understanding entered into on 5/4/2013 between

1. Objectives

- ♦ Project proposal shall be submitted to the coordination committee, which shall review the proposal and give further instructions.

Other areas of training shall also be identified from time to time and updated list shall be submitted to SMT. S.K. GANDHI ARTS, AMOLAK SCIENCE & P.H. GANDHI COMMERCE COLLEGE, KADA. every six months.

2. Exchange / Deputation of Staff

Both, ALPL a SMT. S.K. GANDHI ARTS, AMOLAK SCIENCE & P.H. GANDHI COMMERCE COLLEGE, KADA. jointly agree –

- ♦ That the faculty / staff and research fellows of SMT. S.K. GANDHI ARTS, AMOLAK SCIENCE & P.H. GANDHI COMMERCE COLLEGE, KADA. may visit ALPL for a short period in connection with their research work under collaborative programme.
- ♦ That the faculty / staff and research fellows of SMT. S.K. GANDHI ARTS, AMOLAK SCIENCE & P.H. GANDHI COMMERCE COLLEGE, KADA. deputed for training shall be deemed to be on duty with the SMT. S.K. GANDHI ARTS, AMOLAK SCIENCE & P.H. GANDHI COMMERCE COLLEGE, KADA. for the training period and the TA/DA shall not be borne by ALPL.

3. Joint Conference / Workshop / Courses

- ♦ Both the organizations agree to hold / conduct joint conference / workshop / training courses for SMT. S.K. GANDHI ARTS, AMOLAK SCIENCE & P.H. GANDHI COMMERCE COLLEGE, KADA. faculty / staff / technical personnel within the areas of cooperation.
- ♦ Both the organizations shall initiate and coordinate for such training activities.
- ♦ SMT. S.K. GANDHI ARTS, AMOLAK SCIENCE & P.H. GANDHI COMMERCE COLLEGE, KADA. shall provide accommodation and necessary tools to the participants for such activities at special rates applicable to research and academic institutes.

4. Sharing of Facilities

- ♦ ALPL Shall share at concessional rate, important R&D facilities in order to promote academic and research in the areas of cooperation. Rate will be decided by mutual understanding, depending up on the scope & nature of work.
- ♦ The two organizations agree to exchange software, intellectual property and other in-house components in the areas of cooperation, if found suitable within the framed



rules governing the two organizations. Secrecy and confidentiality while sharing such properties shall be maintained by both the organizations.

- ♦ For collaborative works, access to laboratory, library, software and other essential research tools shall be granted to a limited number of registered M.Sc. / Ph.D. students from SMT. S.K. GANDHI ARTS, AMOLAK SCIENCE & P.H. GANDHI COMMERCE COLLEGE, KADA..

5. Project Work / Dissertation

At any given time, maximum 5 (five) short-listed M.Sc. students from SMT. S.K. GANDHI ARTS, AMOLAK SCIENCE & P.H. GANDHI COMMERCE COLLEGE, KADA. shall be allowed for project work / dissertation in respective areas of specialization at ALPL, subject to availability of resources. The students shall work in the mutually agreeable subject areas identified by both organizations, for a period not exceeding 3 (three) months.

6. Areas of Cooperation

- ♦ Sharing of testing facilities at ALPL at rates mutually decided by two organization depending upon nature of analysis & number of Sample, concession shall be provided on ALPL's prevailing rate list for higher number of samples.
- ♦ Preparation of project reports by ALPL & Smt. S.K. Gandhi Arts, Amolak Science & P.H. Gandhi Commerce College, Kada; which shall be submitted to Government funding agencies by the college.
- ♦ Execution of sanctioned projects shall be done by both the organizations & cost sharing shall be worked out based on contribution by each organization.

7. Coordination Committee

The structure of coordination committee shall be as follows –

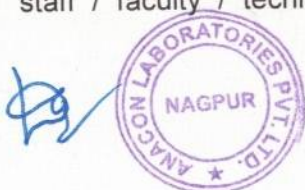
- ♦ Director – Labs , ALPL and/or his nominee(s)

The coordination committee shall –

- ♦ Periodically review the progress of identified programmes.
- ♦ Modify the identified areas of cooperation, if needed.
- ♦ Consider the continuance / extension of MoU.
- ♦ Consider new R&D proposals for collaborative work and implementation on case-to-case basis, including financial arrangements and intellectual property rights (IPR).

8. Publications and Patents

- ♦ The coordination committee shall review significance of collaborative research work and direct, whether or not, a patent / publication be made.
- ♦ Publications arising out of collaborative work shall be co-authored by the concerned staff / faculty / technical personnel / research student of ALPL and SMT. S.K.

- ◆ ALPL and SMT. S.K. GANDHI ARTS, AMOLAK SCIENCE & P.H. GANDHI COMMERCE COLLEGE, KADA. shall jointly hold the IPR / Patent arising out of collaborative research work.
- ◆ Coordination committee shall discuss on ownership, licensing, costs, royalties, etc. of IPR / patent arising out of collaborative research work.
- ◆ Recommendations of coordination committee shall be processed in accordance with the predefined framework of IPR guidelines and rules governed by individual organizations.

9. Non Disclosures

In case of collaborative work, no organization shall disclose any investigation / findings to media / public / unauthorized internal entity in any form, whether electronic / print / verbal, without written consent and approval by coordination committee.

10. Validity

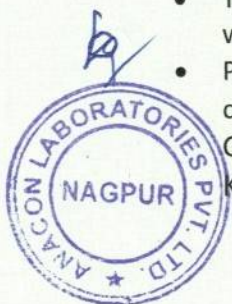
